

**Johnsonville Shopping Centre Summer Fashion Promotion
Terms and Conditions**

1. Information on how to enter and prizes form part of these conditions of entry. Entry into the competition is deemed acceptance of these terms and conditions.
2. The promotion is open to New Zealand residents 16 years and over. Employees of the Promoter and any agency involved with this promotion, including any tenants or retailers at Johnsonville Shopping Centre, and the immediate families of such employees, are not eligible to enter. Immediate family includes the spouse, defacto spouse, child, parent or sibling.
3. The promotion commences at 9:00am on Monday 2 October 2017 and closes at 5:00pm on Tuesday 31 October 2017 ("Promotional Period").
4. To enter the promotion, during the promotional period the entrant must:
 - a.) Spend \$30 or more in a single transaction at any participating Johnsonville Shopping Centre retailer; and
 - b.) Complete the entry form available at participating retailers with details including: Full name; Phone; Suburb; Email Address; Purchase Amount; Store where the purchase was made; and
 - c.) Agree to the Terms and Conditions; and
 - d.) Place the completed form in one of the designated entry boxes throughout the Centre by 5pm Tuesday 31 October; and
 - e.) The Receipt must be kept in case you are the winner.
5. To be eligible, the purchase must be made in one transaction at a qualifying Retailer, and the entry submitted, during the promotional period.
6. Each eligible purchase is only valid for one entry. Only one entry may be submitted for each eligible purchase. A purchase will only be deemed eligible if the receipt is kept.
7. The competition is limited to all of the stores within Johnsonville Shopping Centre (not including Countdown and Beauty Spot (outside Countdown. Purchases of Johnsonville Gift Cards are eligible. Lay-buy receipts are not eligible until the final receipt for the lay-buy is presented.
8. Five provisional prize winners will be randomly drawn from all valid entries at 10am on Wednesday 1 November.
9. The provisional winners will be contacted by phone and email within 5 business days and will be announced the winner once the eligibility of the purchase has been confirmed with presentation of the receipt the entry was made on.
10. There are 5 prizes of \$500 in gift vouchers. The winner will be able to choose their preferred store for the voucher to come from, which include either Max, Black Pepper, Jacqui-E, Just Jeans, or Gloria's.
11. The prize is not transferable, changeable or redeemable for cash.

12. In the event that the prize is not collected within 25 days of the winner being contacted, the Promotor reserves the right to redraw the prize under the original terms of the prize draw.
13. Once awarded, the Promoter is not liable for any prize that has been lost, stolen, forged, damaged or tampered with in anyway.
14. In the event that the prize becomes unavailable for any reason beyond the Promotor's control, the Promotor may in its sole discretion decide to provide an alternative prize.
15. Neither the Promotor nor any other entity associated with this promotion will be responsible for any late, lost, misdirected, corrupted, incomplete or incorrectly submitted entries, including but not limited to entries not received due to technical problems or human error. The time entries are deemed to be made will be the time the entry is received, not the time the entry is submitted by an entrant.
16. The promotor reserves the right to disallow entries in its absolute discretion and without giving reasons.
17. The Promoter reserves the right, at any time, to verify the validity of entries and determine the eligibility of entrants (including an entrant's identity and age) and to disqualify an entry or refuse to award a prize where false or misleading details have been given by an entrant, or where an entrant has behaved in a fraudulent or dishonest manner, or otherwise than in accordance with these terms and conditions or the spirit of the promotion.

By entering this Promotion, entrants agree to the use of their names, photographs, and likeness for promotional/advertising purposes without charge, and agree to make themselves reasonable available for this purpose. The ensuing copyright will rest with the Promotor, without any claim to compensation from the entrants.
19. The prize must be collected in person from Johnsonville Shopping Centre at a time arranged. Arrangement may, at the discretion of the Promoter, be made to deliver the prize to an address in New Zealand.
20. Entrants acknowledge and agree that he or she will comply with all instructions given by employees of the Promoter and other agencies associated with this promotion, and agree not to do anything that may bring the Promotor into disrepute.
21. Entrants agree that as a condition of receiving the prize, he or she may be required to execute a waiver and indemnity in the form provided by the Promoter.
22. If an entrant cannot accept the prize for any reason, that prize will be void and no compensation will be payable.

24. All decisions made by the Promoter, its employees or agents are final and no correspondence will be entered into.

Except for any liability that cannot be excluded by law, the Promoter (including its officers, directors, shareholders, employees, advisors, assignees, agents, licensees, representatives, advertising and promotional agencies), excludes all liability (including negligence), for any personal injury or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where attributable to any of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected; (d) any variation in the prize; € any tax liability incurred by a claimant or entrant; or (f) use of a prize.
